Sub: Fresh Composite Provisional Affiliation upto Senior Secondary level to the above said school under switch over category.

Sir/Madam,

With reference to your online application dated 22.06.2015 on the subject cited above, I am directed to convey the sanction for **Composite Provisional Affiliation for Secondary School Examination and Senior Secondary School Certificate Examination under Switch Over Category** of the Board for a period of three years w.e.f. 01.04.2016 to 31.03.2019. The following subjects have been sanctioned to be introduced at Senior Secondary classes :-

- (a) Languages:- English Core/Elective, Hindi Core/Elective, Sanskrit Core & Elective
(b) Subjects: Accountancy, Biology, Business Studies, Chemistry, Computer Science, Economics, Geograpy, Hisotry, Home Science, Mathematics, Physical Education, Political Science, Psychology & Physics.

The above sanction is subject to fulfillment of following conditions:-

1. The affiliation Code Number allotted to your school is **531322**. This may please be noted and quoted for any further correspondence with the Board.
2. The school will follow the syllabus on the basis of curriculum prescribed by NCERT/CBSE and text books publishing by NCERT/CBSE for the Middle Classes. The school will follow syllabus and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.
3. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X. As per the newly implemented CCE scheme vide Circular No. 39/20-09-2009 dated 20.09.2009, the students of class X will appear in the Summative Assessment-II (SA-II) conducted at the school level only. However, those students of class X, who opt to move out from CBSE system in Class XI to any other Board, will exercise the option to appear in the SA-II conducted at the Board level. Both the students will get the same certificate issued by the Board at the end of class X.
4. It is the case of switch over from State Board; the school is required to withdraw its affiliation from State Board as dual affiliation is not permissible. Also State Board classes IX and XI will not be continued w.e.f. **01/04/2016**. However, for the Class X and XII Examination to be held in the year **2017 & 2018**, the school will sponsor its students for State Board only.
5. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
6. It will increase the number of equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
7. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt from time to time.
8. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII :-
